## 3. F1/FIN/11 DRAFT RATES ESTIMATES 2025/26

#### 1. Purpose

The Purpose of this report was to seek members' approval for

- The Council's Revenue Budget / Estimates for the year 2025/26 and the expenditure and forecast income included therein authorised
- The District Rates for the year commencing 1 April 2025 be fixed at 28.8790p and 0.4297p in the pound for Non-Domestic and Domestic properties respectively.
- 2. Introduction and Background

Members were reminded that under the Local Government Finance Act (Northern Ireland) 2011, the Council:

- Shall consider the estimates for the next financial year;
- May revise the estimates in such manner as the Council sees fit;
- Shall approve the estimates;
- Shall authorise the expenditure included in the estimates; and
- Shall fix for the financial year the amount estimated to be required to be raised by means of rates made by the Council.
- 3. <u>25/26 Revenue Budget / Estimates</u>

A summary of the Council's Revenue Budget / Estimates for the 25/26 financial period and the Draft Rates Calculation 2025/26 were circulated to Members.

The rates proposed would result in a 4.96% increase for domestic ratepayers over the rates struck for the 2024/25 financial year.
