Dear Ellen,

Please find attached some information which forms the Autism NI response to the consultation. The comments from Autism NI are confined to autism specific issues that require prioritisation in this context.

The experiences of the autism community suggest that life is getting more, rather than less, difficult and services are failing to deliver. This is a direct result of a legacy of underfunding which remains unaddressed and a dramatic increase in the prevalence rate. The NI Autism Strategy remains the only UK Autism Strategy without a fully costed and dedicated budget. In addition, there is no coordination regionally across Departments.

Inequalities regarding access to services, external and internal training for the workforce and families, as well as public awareness of Autism, must be addressed as part of required compliance with the Autism Act (NI) 2011.

There is a legal requirement upon all public bodies to take account of the social and communication barriers faced by individuals with Autism in accessing public services and public facilities, e.g.

- improved visual signage and attention to sensory barriers;
- clearly structured public areas delineated by function;
- assessments based upon social functioning, not merely mental and physical ability;
- adjustments to "customer service" procedures that provide for people with Autism;
- specific workforce Autism training to assist compliance and competence;
- information must be conveyed in a literal style with visual prompts when appropriate or required.

With specialist accredited training a range of individuals/agencies can be made more aware of the issues and support the autism community within their remit. The Autism Act (NI) 2011 and subsequent Autism Strategy asks for early identification and appropriate intervention for all ages.

I therefore attach a copy of the Autism Act (NI) 2011 for your consideration.

We are writing to advise you that the Council, in preparation of its new Local Development Plan, are publishing its draft Plan Strategy on 28 June 2019. This notification is being provided by the Council as your information is included in our database of Section 75 (Equality) consultees.

What is the draft Plan Strategy and its assessments?

The draft Plan Strategy is the next key stage in the preparation of our new Local Development Plan. It includes a range of strategic and detailed policies to facilitate and manage development, along with a spatial growth strategy that indicates at a strategic level where different types of development will be promoted.

The draft Plan Strategy is accompanied by a number of assessments including a Sustainability Appraisal incorporating Strategic Environmental Assessment Report (SA/SEA Report), a Section 75 Screening and Rural Needs Impact Assessment Report and a draft Habitats Regulations Assessment (these assessments are also available for public comment). A number of supporting evidence and background papers are also published.

The formal public consultation of the draft Plan Strategy will run for a period of 8 weeks, commencing on **Friday 26 July 2019**, **and closing at 5 pm on Friday 20 September 2019**. The draft Plan Strategy is published alongside a range of assessments, which are also open for public consultation at this time. Please note that representations received after the closing date on Friday 20 September 2019 will not be considered.

Autism Act (Northern Ireland) 2011

2011 CHAPTER 27

An Act to amend the Disability Discrimination Act 1995 and to require an autism strategy to be prepared. [9th May 2011]

B^E IT ENACTED by being passed by the Northern Ireland Assembly and assented to by Her Majesty as follows:

Amendment to Schedule 1 to the Disability Discrimination Act 1995

Amendment to Schedule 1 to the Disability Discrimination Act 1995 (c. 50)

- 1.—(1) The Disability Discrimination Act 1995 is amended in its application to Northern Ireland as follows.
 - (2) At the end of paragraph 4(1) of Schedule 1 insert—
 - "(i) taking part in normal social interaction; or
 - (j) forming social relationships"

The Autism Strategy

Autism strategy

- 2.—(1) The Department must prepare a strategy on autism to be known as the autism strategy and must publish the autism strategy not less than two years after the passing of this Act.
- (2) Before preparing the autism strategy, the Department must consult the Northern Ireland departments on it.
- (3) The Department must request every HSC trust to provide data on the prevalence of autism in its area in order—
 - (a) that it can publish and update the strategy; and
 - (b) that the Northern Ireland departments can effectively implement the strategy.
- (4) The HSC trusts must provide the Department with all information it requests under subsection (3).

- (5) The Department must keep the autism strategy under review and must publish a revised strategy at intervals of not more than seven years.
- (6) The Department must monitor the implementation of the autism strategy by the Northern Ireland departments.
- (7) The Northern Ireland departments must co-operate with the Department in relation to the preparation, review and implementation of the autism strategy.
- (8) The Northern Ireland departments must implement that part of the autism strategy which falls within their responsibilities and the Department must implement that part of the autism strategy which falls within its responsibilities.
- (9) Not more than three years after the publication of the autism strategy, and at intervals of no more than three years thereafter, the Department must prepare a report on implementation of the autism strategy by the Northern Ireland departments and the Department.
- (10) The Minister shall lay a report prepared by the Department under subsection (9) before the Assembly as soon as possible after its preparation.

Content of the autism strategy

- 3.—(1) The autism strategy must set out how the needs of persons with autism are to be addressed throughout their lives.
- (2) Without prejudice to the generality of subsection (1) the needs to be set out in the autism strategy shall include the health care, educational and social needs of persons with autism.
- (3) The autism strategy must set out how the needs of families and carers of persons with autism are to be addressed.
- (4) The autism strategy must set out the Department's proposals for promoting an autism awareness campaign.
- (5) The Department may make regulations as regards the content of the autism strategy.
- (6) No regulation may be made under this section unless a draft of the regulation has been laid before, and approved by resolution of, the Assembly.
- (7) Before making a regulation under this section the Department must consult the Northern Ireland departments and other such persons as the Department thinks appropriate.

Supplementary

Interpretation

- **4.**—(1) In this Act, unless the context otherwise requires—
- "autism" means autism, Asperger's syndrome, Rett's syndrome, Heller's syndrome or any pervasive developmental disorder not otherwise specified;
- "autism strategy" means the strategy required to be published under section 2;
- "carer", in relation to a person with autism, means an individual who provides a substantial amount of care on a regular basis for that person;

- "the Department" means the Department of Health, Social Services and Public Safety;
- "HSC trust" refers to a body established under Article 10 of the Health and Personal Social Services (Northern Ireland) Order 1991 (NI 1);
- "the Minister" means the Minister of Health, Social Services and Public Safety;
- "Northern Ireland department" means the Department of Culture, Arts and Leisure, the Department of Education, the Department for Employment and Learning, the Department of Agriculture and Rural Development, the Department of Enterprise, Trade and Investment, the Department of the Environment, the Department of Finance and Personnel, the Department of Justice, the Department for Regional Development, the Department for Social Development and the Office of the First Minister and deputy First Minister.

Commencement

5. This Act comes into operation after the end of the period of three months beginning with the day on which it is passed.

Short title

6. This Act may be cited as the Autism Act (Northern Ireland) 2011.
