



Open Call for Social Partners for the Antrim and Newtownabbey PEACEPLUS Partnership

Antrim and Newtownabbey Borough Council are establishing a Partnership to oversee the design, development and implementation of a Co-designed Local Community Action Plan for the new PEACEPLUS Programme (2022-2027).

As part of this process, we are seeking to recruit Social Partners who will play a vital role on the PEACEPLUS Partnership. We invite applicants who live or work within the Antrim and Newtownabbey area and can represent the various District Electoral Areas (DEAs) within the Borough as well as being representative of different sectors, communities, underrepresented groups and PEACEPLUS target groups from across the council area.

We would like to achieve a balanced and representative PEACEPLUS Partnership and welcome applications from a wide range of individuals. Applicants should have relevant expertise and knowledge of the local area to enable them to contribute to the PEACEPLUS Programme.

The role is voluntary and advisory in nature.

This pack gives you background information about the PEACEPLUS Programme, what we mean by a social partner and an outline of the social partner application process.

What is PEACEPLUS?

The PEACEPLUS Programme is a €1.14bn investment in the social, economic and environmental development of Northern Ireland and the border counties of Ireland. It comprises six themes, which encompass 21 individual investment areas.

Local Authorities will be delivering their plans under Investment Area 1: Building Peaceful and Thriving Communities, specifically Theme 1.1 Co-designed Local Community PEACE Action Plans, with a provisional figure of €110m for the 17 participating local councils in Northern Ireland and the border counties.

Co-designed PEACEPLUS Local Community Action Plans will be produced for each of the 17 local authority areas across the Programme area. These will be designed to complement community planning structures and plans. A co-design approach enables groups which represent different communities of interest from defined areas, to collaboratively design projects tailored to meet the challenges and opportunities specific to that area. The PEACEPLUS Action Plan will enable diverse partnerships to establish and invest in key actions for their local areas and collectively address these in a manner which will make a significant and lasting contribution to peace and reconciliation. The plans will comprise priority projects and initiatives, which have been co-designed by communities at the local level. The co-design process itself should enable cross community engagement and collaboration.

The plan will be centred around three core themes:

- 1. Local community regeneration and transformation
- 2. Thriving and peaceful communities
- 3. Building respect for all cultural identities

The plan will enable and empower the partnership to self-determine and deliver priority projects on a cross community basis, which will result in improved, shared and inclusive local services, facilities and spaces, and make a significant and lasting contribution to peace and reconciliation. It is proposed the plans will span the range of activities included within the PEACE PLUS Programme, e.g. youth development programmes; health and wellbeing initiatives; community regeneration projects; redevelopment and reimaging of existing community facilities for shared use; initiatives to build positive relations; social innovation; social enterprise and education/ skills development programmes; all designed to address issues of racism and sectarianism, increase social inclusion and promote civil leadership.

What is the PEACEPLUS Partnership?

The PEACEPLUS Partnership will oversee and be responsible for the design, development and implementation of the Local Community Action Plan.

It will be representative of the community from across the Antrim and Newtownabbey Borough Council area and will comprise: 12 nominated Elected Members; 4 nominated Statutory Body Representatives and 7 Social Partners representing each District Electoral Area (DEA) within the Borough as well as being representative of PEACEPLUS Target Groups. Social Partners will be chosen through this open call selection process.

The diagram below shows the proposed structure the Partnership will adopt. The partnership must ensure a strong cross-community and Section 75 focus.

The PEACEPLUS Programme is expected to run until 2027, membership will last for the length of the programme. Circumstances can change for individuals, but those applying should have the intention of staying in post for the duration of the Partnership as far as is possible.

What is a social partner?

A social partner includes those within the community, voluntary and social enterprise sector; those from special interest groups or those representing Equality Groups; individuals from civic society; and those from PEACE target groups, trade unions and businesses. The role of a social partner is to represent the sector from which you have been nominated (not your individual organisation) and to represent the interests of the wider community.

What are PEACE PLUS target groups?

PEACE PLUS target groups include women, young people, older people, those living with a disability, members of the LGBTQI+ community, those particularly impacted by the legacy of the Conflict (such as victims and survivors), and those dealing with legacy issues (such as exprisoners and former members of the security forces), as well as ethnic minorities, migrants, asylum seekers and members of the Traveller Community.

What are Section 75 groups?

All public authorities must have due regard to the need to promote equality of opportunity between Section 75 groups¹. There are nine groups which include persons of different: religious belief, political opinion, gender, racial group, age, marital status, sexual orientation, persons with a disability and those without and persons with dependants and those without.

Commitment

This is a voluntary appointment with travel costs and minor expenses reimbursed. The time commitment is anticipated to be a minimum of 6-8 meetings per year (1-2 hours long). At particular stages of the PEACEPLUS process this may intensify. Partnership members may be asked to participate in relevant subgroups or assessment panels. They will also be asked on occasion to represent the Partnership at project launches or events. Members work in the public interest, not an individual or group interest.

Partnership role in co-design process

¹ Section 75 of the Northern Ireland Act 1998 provides that: (1) A public authority shall in carrying out its functions relating to Northern Ireland have due regard to the need to promote equality of opportunity- (a) between persons of different religious belief, political opinion, racial group, age, marital status or sexual orientation; (b) between men and women generally; (c) between persons with a disability and persons without; and (d) between persons with dependants and persons without. (2) Without prejudice to its obligations under subsection (1), a public authority shall in carrying out its functions relating to Northern Ireland have regard to the desirability of promoting good relations between persons of different religious belief, political opinion or racial group.





Members will play a significant role in the co-design process. A co-design approach goes beyond consultation with local communities about needs relevant to the programme. It will also be seeking and designing clear project ideas to meet those needs. Our bid for funding will have to detail the specifics of those projects. Partnership members will, among other things, play a key part in the process of helping to select and prioritise those projects that best meet the specific peace building criteria of the funding stream, address local demand and need, and are meaningful, deliverable and cost effective.

Social Partner Specification

We are seeking enthusiastic and knowledgeable individuals or representatives (including volunteers) of constituted Community and Voluntary Sector organisations, based within our council area. The individuals and organisations should be representative of one of the District Electoral Areas (DEA) of the Borough. They should also have expertise relevant to the PEACEPLUS programme Theme 1.1. and/or identity with / represent PEACEPLUS Target Group.

The partnership will consider participation of traditionally under-represented groups, including women, young people and those with a disability. All applicants are requested to complete an equality monitoring form.

The Social Partner open call is seeking a diverse skillset and representation for the Partnership. Applicants will meet one or more of the following:

- 1. Live within, or represent a Community & Voluntary Sector organisation from, an ANBC District Electoral Area Airport, Antrim, Ballyclare, Dunsilly, Glengormley, Macedon, Threemilewater.
- 2. Represent a Section 75 group e.g Gender, Age, Disability, Race, Religious belief, LGBTQIA+
- 3. Work or volunteer (or a strong element of their work) is in the field of Good Relations / peace and reconciliation / dealing with the legacy of the past.
- 4. Represent a sector of specific relevance to the PEACEPLUS programme e.g., Irish or Ulster-Scots language/ culture, Faith / Inter-faith based organisations, those impacted by the legacy of the past (e.g. victims and survivors, those dealing with legacy issues such as exprisoners, former members of the security forces), organisations who have a significant track record of delivering peace and reconciliation work through any field of expertise.

Social Partner waiting list from open call process.

Once all Social Partner positions are filled, a waiting list of suitably experienced and qualified applicants will be created. In the instance of a Social Partner position becoming vacant during the lifespan of the programme, it will be offered to the next person on the list.

Selection Process

Social Partner will be appointed on the basis of information provided on the application form. Please assume no prior knowledge of yourself or the organisation you represent.

Wider Consultation

Please note that being a Partnership member is not the only way to be involved with PEACEPLUS Theme 1.1. There will be a much wider local consultation and open opportunities for engagement in the co-design process during 2022. We would encourage as many people and organisations as possible to engage with that wider process.
