In accordance with Regulation 15 of The Planning (Local Development Plan) Regulations (Northern Ireland) 2015 notice is hereby given that Antrim and Newtownabbey Borough Council is publishing its Local Development Plan 2030 – draft Plan Strategy.

The draft Plan Strategy along with supporting documentation, including a Sustainability Appraisal (incorporating a Strategic Environmental Assessment), a draft Habitats Regulations Assessment, and an Equality (Section 75) Screening and Rural Needs Impact Assessment, as well as other background supporting evidence will be available for a period of 8 weeks public consultation commencing on Friday 26 July 2019 and closing at 5pm on Friday 20 September 2019.
