Karl Property Investments set out they consider the DPS is sound but advocate that Karl Business Park and adjacent lands are brought within the Airport SEL, a matter for Local Policies Stage, and to be considered against DM1. We would re-iterate our previous correspondence identified that BIA consider the extent of the SEL should align with the current operational area of the airport which is sufficient to facilitate appropriate future development and growth of the SEL centred on the BIA.

Karl Property Investments set out they consider DM13.1 & DM13.2 to be unsound when considered against CE2 & CE4 Soundness Tests. To make the policy sound Karl suggests consideration should be given to existing properties within the vicinity of the airport; however, we would point out that this is the BIA – Operations Policy and designed to address development necessary for the maintenance of current operational requirements of the airport or expansion of airport facilities. It is therefore inherent that this policy remains specific to the operational requirements of BIA.

BIA considers that the asserted reasons for unsoundness in the plan, points of objection and promotion of alternative policy raised by Karl Property Investments are incorrect and misplaced.
