# The Dogs Exclusion (Antrim and Newtownabbey Borough Council) Order 2025

Antrim and Newtownabbey Borough Council makes the following Order -

### Commencement

1. This Order comes into operation on (date to be inserted)

# **Application**

2. This Order applies to the land specified in the Schedule

### Offence

- (1) Any person in charge of a dog is guilty of an offence if, at any time, the person takes the dog onto, or permits the dog to enter or remain on, any land to which this Order applies unless;
  - (a) the person has a reasonable excuse for failing to do so; or
  - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to the person doing so.
  - (2) For the purposes of this Article a person who habitually has a dog in their possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.
  - (3) For the purposes of this Article a person who habitually has a dog in their possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

## **Penalty**

**4.** A person guilty of an offence under Article 3 is liable on summary conviction to a fine not exceeding level 3 on the standard scale.

## **Revocation**

- **5.** From and after the date on which this Order comes into operation, the following Orders relating to the exclusion of dogs in designated areas shall be and are hereby revoked:-
  - (a) The Dogs Exclusion Order made by Antrim Borough Council on 10<sup>th</sup> day of October 2013
  - (b) The Dogs Exclusion Order made by Newtownabbey Borough Council on 20<sup>th</sup> day of December 2012
